# **HOW WILL AI CHANGE MEDICINE IN THE NEXT 5 YEARS**


#### PRESIDENT'S MESSAGE: Ryan Lundquist, MD

ne can find news articles about how artificial intelligence (AI) will never completely replace physicians, and others that claim physicians will become obsolete.

Who is correct? Maybe we should ask AI? So I posed that question to ChatGTP, one of the leading AI programs. Here is its response:

"In the next 5 years, artificial intelligence (AI) will revolutionize medicine by improving diagnosis accuracy, predicting patient outcomes, and streamlining administrative tasks.

Al-powered tools will assist doctors in analyzing large amounts of medical data, including patient histories and lab results, to identify patterns and make more accurate diagnoses. Al algorithms will also help predict the likelihood of patient readmission and enable doctors to provide personalized treatment plans. Moreover, Al will automate administrative tasks, freeing up time for healthcare professionals to focus on patient care. Overall, Al will enhance medical decision-making, improve patient outcomes, and reduce healthcare costs."



According to ChatGTP, AI could have a significant positive impact on our work lives by improving our efficiency. However, significant gains in efficiency may only provide temporary



improvement before increasing workloads and decreasing reimbursement follow. The increasing presence of a private equity model in medicine could also put more pressure on that transition.

My next question to ChatGTP was if it would ever replace doctors completely. This is its response:

"While artificial intelligence (AI) will undoubtedly change the way healthcare is delivered, it is unlikely to fully replace doctors. Al can analyze vast amounts of data and assist with medical decision-making, but it cannot replace the human touch and empathy that comes with patient care. Doctors use their experience, knowledge, and intuition to make complex decisions that take into account the unique needs and circumstances of each patient. Al can support doctors in this process, but it cannot fully replace the expertise and judgment of a trained medical professional. Additionally, there are certain tasks, such as performing surgical procedures, that require human skills and dexterity that cannot be replicated by machines."

Are we to trust AI that everything will be great, and our lives will only improve with the growing infiltration of AI? Or, does AI want us to believe everything will be better?

Although Al is undoubtedly becoming more intelligent, it is still, in part, dependent on the programmers who created it. How are we to insure there will be no bias? Unfortunately, that might be impossible. If you were a company developing this technology, you would want it to succeed, and therefore you would have motive to convince everyone how it will improve their lives.

So will Al improve our lives in the future by eliminating unwanted tasks? Probably. But, it may also have unwanted consequences that we may not foresee. In any event, time will tell and the future will be interesting.

## **FMA'S POLICY ON ARTIFICIAL INTELLIGENCE**

As a result of the emerging potential of AI systems in the medical field — and the questions and potential concerns that these systems raise — the FMA Medical Student Section introduced Resolution 22-306 Artificial Intelligence at the 2022 FMA Annual Meeting. This policy was referred to the Board of Governors, which assigned the resolution to the FMA Council on Medical Economics and Practice Innovation. ## **BUSINESS PREPAREDNESS STRATEGY: HELP FROM THE HORIZON COUNCIL**

arlier this year I was nominated as a board member of The Horizon Council. The Horizon Council was established in 1991 as a public-private alliance that will advise the Lee County Board of Commissioners on economic development issues.

The Council has up to 80 members representing different business sectors within Lee County, Florida. It is a privilege for me, as your Executive Director, to represent the physicians of our community.

As part of The Horizon Council, I joined the business issues committee to pursue more knowledge and education on how to help physician offices during disasters that likely will affect their businesses (i.e., hurricanes, pandemics, etc.). This committee's goal is to develop a "business preparedness strategy" that any local business owner can employ during the next disaster.

### As many of you know too well, having a disater plan is the first step in survival.

In order to best represent your voice in the process, I invite you to **send me an email message** that includes the critical lessons you learned from your team's experience during a recent past disaster.

My role on this committee provides you with an opportunity to share your best practices before, during, and after an event. We want to know:

- What special measures did you take before the event?
- Did these measures meet your expectations?
- What problem(s) arose that wasn't in the plan?
- How did you remedy it?
- What changes are you making to your disaster plan moving forward?
- What would you recommend other businesses, or the county, do differently during the next disaster?
- What new best practices are helping your recovery?

## NEW ONE-TIME DEA REGISTRATION RENEWAL REQUIREMENT

If your DEA registration renewal is on or after June 27, 2023, you will need to satisfy a one-time requirement that shows you completed eight (8) total controlled substance CME in order to maintain your license to prescribe Schedules II, III, IV, and V drugs.

**NOTE:** Any substance abuse CME you obtained from a recognized training provider in the last two years count toward this total, including the substance abuse course that was offered by LCMS in January. Be sure to obtain and save your certificates of completion as they may be used to verify your compliance by DEA.

This new requirement, outlined in the Medication Access and Training Expansion Act (MATE), applies to all initial and renewing applicants.

# DOH & LCMS TEAM UP TO ACTIVATE 6-COUNTY MEDICAL RESERVE CORPS

he need for the Medical Reserve Corps (MRC) became apparent after the 9/11 terrorist attacks, when thousands of medical and public health professionals, eager to volunteer in support of emergency relief activities, found that there was no organized approach to channel their efforts. As a result, the MRC was established to provide a way to recruit, train, and activate medical and health professionals to respond to community health needs, including disasters and other public health emergencies. MRC units engage both medically trained volunteers and those without healthcare backgrounds to strengthen public health, improve emergency response capabilities, and build community resiliency.



Common activities MRC members volunteer for are emergency preparedness and response trainings, disaster sheltering, emergency medical support, vaccination clinics, and health education. Recently, the MRC in conjunction with the Lee County Medical Society, responded to healthcare needs in Sanibel post-Hurricane Ian to provide healthcare services like giving stitches and vaccinations. Strengthening a community's "everyday" public health and medical infrastructure, and its emergency preparedness and response capacity, leads to stronger community resiliency.

The Florida MRC Network is comprised of 33 MRC units covering all 67 Florida counties. The local chapter, Southwest Florida MRC, includes six counties: Lee, Charlotte, DeSoto, Highlands, Hendry, and Glades. The MRC makes up some of the most robust volunteer protections in the US, while developing a network of community-based teams of volunteers who are interested in strengthening public health. 

# **LESSONS IN PREVENTING BUTTON BATTERY INJURIES**

ccording to a study published in *Pediatrics*, it is estimated that between 2010 and 2019, more than 70,000 emergency department (ED) visits in the United States were battery related among children under 18 years old.

The majority of ingestions, exposures, and insertions go unwitnessed by the parent or caregiver. Clinicians may be misled by the patient's initial presentation because symptoms are often nonspecific.

The child may have delayed symptoms that can result in delayed treatment and lead to serious injury.

#### **Case Example**

A mother took her child to urgent care with complaints of nasal trauma and swelling. Although x-rays were negative for fracture, they revealed a foreign body in the child's left nostril. The radiologist noted on the report that he informed the mother of this finding.



The urgent care staff instructed her to take the child to the pediatrician. The child was seen by an advanced practice clinician (APC), but the records from urgent care were not made available and there were no documented attempts by the APC to obtain the records.

On exam, the child was noted to have nasal swelling, bruising around the left eye and bridge of nose, and dried blood around the left nostril and upper lip. Follow-up facial/ skull/orbital x-rays were ordered, and the mother was told to return for follow-up in three days. The mother did not complete the x-rays and was a no-show for the return appointment. She returned with the child to the pediatrician's office due to intermittent nosebleeds. The pediatrician diagnosed nosebleeds due to dry weather and nose picking.

The mother returned one month later and was seen by a different pediatrician. The child presented with malodor from the nose with purulent green discharge from both nostrils. The child was referred to an otolaryngologist (ENT).

Later, the child presented to the ED with a large nosebleed. He was examined by an ENT, who confirmed a foreign body in the nose and surgically removed it. The child was found to have a large anterior nasal septal perforation as the button battery had decomposed and leaked acid that had eroded through the nasal septum into the bone.

The family filed a lawsuit against the urgent care facility, radiologist, APC, and pediatricians, alleging delayed diagnosis and treatment that resulted in severe injury.

Contributing factors in this case include the following:

- Failure by urgent care staff to communicate x-ray results.
  Failure by the APC to obtain medical records from urgent care.
  Failure by the second pediatrician to document that the mother did not obtain
- the x-rays recommended.
- Failure by the mother to provide an accurate history, relay accurate x-ray results, obtain follow-up x-rays, and bring the patient to appointments.

#### **Patient Safety Strategies**

To minimize misdiagnosis and delays in care and treatment, maintain a high index of suspicion for foreign body ingestion, aspiration, or insertion in the mouth, nose, or ears. It is important to obtain an

accurate history, perform a thorough diagnostic workup, and review prior patient records. Thorough documentation serves as a powerful defense in claims alleging misdiagnosis or delayed treatment.

Prevention is key and should include raising community awareness. During well-child visits, take the opportunity to educate parents and caregivers. Post the telephone number of the **National Battery Ingestion Hotline—(800) 498-8666**—in each exam room and make it readily available to clinicians. Safe Kids Worldwide offers a button battery tip card to download or post on your website. The CPSC offers posters on button battery safety.
