SUMMARY OF RECENT TRIAL LAWYERS CONFERENCE ON PROFESSIONAL LIABILITY SUITS

It was reported to the Council on Legislation and Regulations that a conference of trial lawyers was recently held to educate attorneys on how to more effectively and efficiently sue physicians. It was stated that because of the "no-fault" automobile law, attorneys are looking, in increasing numbers, to the medical malpractice field as a source of income. The following general concepts were suggested:

- 1. When a complaint comes to the attorney, he should suggest that the client go to the hospital and get a copy of his medical records.

 (No mention of an attorney is to be made to the hospital)
- 2. The attorney then reviews the medical record and if there appears to be a potential case, he advises the client to to go the physician. He is to take a reliable witness -- e.g., minister -- and ask certain key questions of the physician about his case. (These questions are obtained from publications available to attorneys) The physician, it is hoped, because of not knowing an attorney is involved will not exercise appropriate caution in answering the questions. He will thus open himself to possible suit.
- 3. The patient is to immediately go back to the attorney and he and the witness give their depositions.
- 4. The attorney then sends all the data to physicians who are paid a fee to render opinions on areas of potential malpractice. They send to the attorney their opinions as to his best avenues for suit.
- 5. After receiving the above recommendations as to areas of suit, the attorney then officially asks for the medical records from the hospital and physician. (He hopes that in the interim some of the records may have been altered as he still has the copy the patient got)
- 6. Everyone even remotely connected with the action is then sued. The strategy here is to get some allied professional, because of personal fear, to break down and put "finger" on the physician.

The above procedures allegedly will result in more and higher settlements.
