

own state legislators finally realizing the crisis that is medical malpractice in the state of Florida. Although none of us feel that the current legislation is going to make too much difference in the rates we pay, I can assure you that the Trial Lawyers see this as the first chink in their armor. They are beefing up for a major fight this year so be ready. Our own constitutional amendment is a great threat to their money machine - you can rest assured that they will not go down without a fight.

We will need to be vigilant in the face of such a tenacious enemy - but it does feel good to finally be proactive rather than defensive. The federal government has not been able to achieve reform but they will not be able to skirt the issue much longer. Those whopping 1.5% increases in Medicare rates are unlikely to match the nationwide increases in malpractice and other expenses required to run a medical practice. So the showdown remains.

Please, remember to support your local, state and federal medical organizations because they are the only ones out there fighting for you and your patients. We need everyone to collect signatures to get the amendment on the ballot! We need everyone to send their financial contribution to this campaign - without sufficient funding it will not succeed. And we need to succeed in this endeavor,

I will enjoy this year as your president. While there are many substantial issues to address, for now I wish for each of you to have a year full of happiness and joy.

PETITIONS PETITIONS PETITIONS THE MEDICAL LIABILITY CLAIMANT'S COMPENSATION AMENDMENT

The Medical Liability Claimant's Compensation Amendment is a constitutional amendment to limit lawyer contingency fees. This amendment in no way reduces the amount a lawyer receives for his work. It only limits the amount he receives from the award. The vast majority of the award will go where it belongs - to the patient in a medical liability case. So, thanks to this proposed amendment, the lawyer gets paid for his work not for the patient's suffering.

Citizens for a Fair Share, Inc. is a statewide organization that is working with the Florida Medical Association and the state medical societies to put this initiative before the Florida voters on November 2004's ballot. It is very expensive to pass an amendment and to ensure their success they are accepting donations. The physicians of the Lee County Medical Society have stepped up to the plate and made over \$41,000 in contributions.

Florida law requires that over 450,000 signatures from registered voters be obtained and verified in order for this proposal to be placed on the ballot. Lee County has been asked to obtain 50,000 petitions. As of December 15, 2003 only 4,577 petitions have been sent in to the Lee County Medical Society office. Please keep in mind that not all petitions that are sent in to the Supervisor of Elections are valid. The majority of discounted petitions were because the signer was not registered to vote in Lee County. Therefore it is very important that a person be a registered voter in order for the petition to be counted. One physician office has voter registration forms right in their office. Physicians and their offices should keep collecting petitions until we reach our goal. Five hundred members times 100 good petitions equals 50,000. Please protect your profession by participating.

As I Recall...

LEE MEMORIAL HOSPITAL

The old Lee Memorial Hospital (the two-story brick one on Cleveland) was opened in 1943 with 30 beds and served as the "new" Lee Memorial (with many modifications to reach a 160 bed count) until the present eight-story Lee Memorial opened in 1968. During 2004 this historic structure is destined for demolition, and I feel a great personal loss that much history of medicine in Lee County and Southwest Florida is departing. This is the first of several articles to commemorate the old worn out structure. It was my pleasure to begin practicing surgery at this fifteen-year-old hospital in August 1958, and I learned much about not only medicine but also life in general. Incidentally, I was the last surgeon to operate at this old hospital so now a memory begins. We were slated to move to the new LMH between cases in 1968 (no one recalls the exact date), and I was to perform the first operation in the big new Lee Memorial Hospital, but fate was against me as my case was longer than expected. When we came out of the last remaining operating room, it was like a scene from the "Twilight Zone". The operating suite was completely stripped and moved to the new one leaving us totally alone!

Warren Hagen did the first operation in the new big hospital. (I do, however, have the record for treating the first patient at the new LMH. During the construction, a workman fell two floors through the steel beams and was injured. I was called to climb the ladders to see him as he lay upon a beam with a back injury.) How could I get off the track so soon... but now back to the original story.

I must rely on other sources for information before 1958. The first Lee Memorial (1916) at Victoria and Grand had expanded as much as possible to accommodate 22 patients so in 1939 Bail and Associates (a Ft. Myers firm) drew plans for the new 30 room Lee Memorial Hospital to be located on Cleveland Avenue facing west. It has always been a puzzle to me exactly why the non-air conditioned hospital would face west (the hot afternoon sun). The plan did face it away from the busy, noisy Cleveland Avenue (the only road completely through Fort Myers). In the years before A/C there were open windows and always road signs stating "QUIET HOSPITAL ZONE". Patient rooms faced west and this would get more warmth in the cooler evenings. The morning sun would shine from the east onto a hallway along the back of the rooms allowing the patients to bask in the cooler morning sun and perhaps patients enjoyed the cooler East porch in the heat of the day. Well, these are my theories, and it is doubtful that one will ever know the right answers.

The construction was begun in about 1939(?) by the Works Progressive Administration (W.P.A. was a federal agency in the Great Depression to create jobs for the unemployed). It was a standing joke that if a WPA laborer laid more than one brick or moved a shovelful of dirt that was a days work. Not much progress was made until the U.S. Army took command to have a completed hospital to support the World War II troops stationed in Fort Myers. The "new" 30room Lee Memorial Hospital opened its doors on April 18,

One thing good to come from the WPA office was Sara Nell Gran's introduction of Lil Tooke and Abbott Kagan; their subsequent marriage, and the production of Abbott II and John. PLEASE SAVE THIS ARTICLE FOR REFERENCE in subsequent articles on this old building.

Thank you Ralph Gregg for your skillful executive direction this past year. Welcome to the smiling face of Doug Stevens across the page and may you have a great presidential

LICENSURE RENEWALS

Licensure renewal packets for half of all Florida MDs were sent out on October 6. The licenses of these approximately 25,000 MDs will expire on January 31, 2004, so it is important to respond accordingly. The remaining Florida MDs were issued 3-year licenses in January 2002 (in order to stagger the renewal years), and will not receive renewal notices until October 2004, with their licenses expiring in January 2005. The physicians renewing next year DO NOT need more than the required 40 hours of CMEs.

If you have NOT yet received a licensure renewal packet, do the following:

- Check your license for the expiration date. If it says January 31, 2004, you should have received a packet.
- You may obtain the necessary forms and information by visiting: www.doh.state.fl.us/mqa/ medicalme renewal.html
- 3 Print out both a renewal form and a financial responsibility form (they are listed separately).
- Follow the directions for sending the two forms and your check to the Department.
- 5. If you have questions that aren't being answered at the Web site (www.doh.state.fl.us/mqa) call 850-488-0595

If you did not receive your renewal packet and should have, it may be that the Department does not have your current mailing address. You can check this by calling 850-488-0595. If you need to update your address, you may go to http://www.doh.state.fl.us/mga_and click on How Do I Change My Address.

PUTTING YOUR LICENSE ON INACTIVE STATUS

Florida Board of Medicine

If you are thinking about putting your license on inactive status, consider the following:

- The initial inactive fee is the same as the renewal fee; thereafter the rate is reduced.
- An inactive license still requires payment of the NICA assessment and completion of your Florida CME requirements, including the statutory mandated courses of HIV/AIDS, Domestic Violence and Medical Errors.
 - The inactive license must be renewed every biennium.

To reactive an inactive license requires the following:

- The reactivation fee
- Proof of completion of 20 hours of continuing medical education (CME) for each year on inactive status, including the statutory mandated courses of HIV/AIDS, Domestic Violence and Medical Errors. All CME's must be category I and approved by the American Medical Association (AMA).
- If your license has been inactive for more than two consecutive biennial licensure cycles and you have not practiced at least 2 years of the immediately preceding 4 years in another jurisdiction you shall be required to appear before the Credentials Committee of the Board and establish your ability to practice with the care and skill sufficient to protect the health, safety and welfare of the public, and
- Demonstrate successful completion of the Special Purpose Examination (SPEX) with a score of at least 75 achieved within the year immediately proceeding the appearance before the
- Account for any medical activities related to the practice of medicine in this or any other jurisdiction during the period that the license was inactive and establish an absence of medical malpractice judgments, settlements or disciplinary actions pending in any jurisdiction;
- Prove compliance with the financial responsibility law;
- Additionally, you may need to:
 - Update your fingerprint card including the processing fee.
 - Update the mandatory practitioner profile questionnaire packet.
 - Provide verification of compliance with the Florida Birth-Related Neurological Injury Compensation Association (NICA).
 - Provide certification from each Medical Board of every state in which you are now or have ever been licensed to practice medicine.

MEDICAL INTERVENTION AND DOMESTIC VIOLENCE

Many victims of domestic violence never call the police, go to court, or flee to a shelter. A great number, however, do visit doctors and hospitals for treatment of injuries and stress related illnesses.

Statistics show that 1 in 4 female patients are experiencing abuse. While it is agreed that women experience more threatening forms of assault, it is important to keep in mind that men can experience abuse as well. Pregnant women, children, persons with disabilities and elders are at high risk to be abused.

The physician's recognition and validation of a victim's situation is important. Silence, disregard, or disinterest convey acceptance of the violence in their lives. In contrast, recognition, acknowledgement, and concern confirm the seriousness of the problem and the need to address it. However, victims (18-65 years of age) have the right to report to authorities or not to report in cases where the injuries are not life threatening. Reporting without the victim's permission may put the victim in greater danger.

The AMA has developed a listing of indicators that health care providers can look for as keys to diagnosing abuse. Educational programs, including screening techniques, may be provided for your staff free of charge from Abuse Counseling and Treatment, Inc. at 239-939-2553. You may also call to order brochures and/or cards free of charge for your waiting rooms, restrooms

As medical professionals you have the power to greatly impact the life of victims of domestic violence and their children. Confidentiality, screening, support, documentation, and respect for the patient's decisions can be a lifeline for victims of abuse.





At the November 20, 2003 General Membership Meeting the following Physicians were elected as your - 2004 BOARD OF GOVERNORS.

DEPARTMENT OF HEALTH OFFICIALS ENCOURAGE ONLINE LICENSE RENEWAL

Officials from the Florida Department of Health (DOH) are encouraging Florida's health professionals to "Save Time, Renew Online" at www.doh-mqaservices.com. Earlier this month, DOH Deputy State Health Officer Bonnie Sorensen, M.D., M.B.A., joined the ranks of doctors, dentists and other health professionals utilizing the e-renewal system.

Licensees eligible for online renewal will receive an online account ID and password with their renewal notice. They can renew online by simply going to www.doh-mqaservices.com and clicking on "Renew My License." Licensees can also utilize the site to change their address and update their licensure profile.

The system allows practitioners to update their mailing and practice location addresses and to confirm licensee information maintained by DOH. Online renewals are processed immediately, with license status being updated online within seven business days. Additionally, practitioners renewing online will receive a temporary licensee before logging out of the system.

The system will be available for this biennium's medical doctor renewals until midnight EST on January 31, 2004.
